All Members at the sound of my voice, please come to the Senate Floor immediately. We will be going to the Order of 3rd Readings. We will be going to Order of Senate Bills 3rd Reading, page 12. Senate Bill 729. Senator Silverstein. Mr. Secretary, please read the bill.

SECRETARY ANDERSON:

Senate Bill 729.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR LINK)

Senator Silverstein, on your bill.

SENATOR SILVERSTEIN:

Thank you, Mr. President. This prohibits a person from operating a motor vehicle while a person is smoking if there are -- persons under the age of eighteen in the motor vehicle. The bill imposes a fine of a hundred thousand {sic} dollars. And it states that an officer may not state -- stop or detain a vehicle

solely due to a violation or suspected violation of this Section. I'll take any questions.

PRESIDING OFFICER: (SENATOR LINK)

Is there any discussion? Senator Syverson, for what purpose do you rise?

SENATOR SYVERSON:

Thank you, Mr. President. I didn't really hear the explanation of that. Could he -- could we get a little more -- hear from him and...

PRESIDING OFFICER: (SENATOR LINK)

Can we keep the noise on the Floor down, please? Senator Silverstein.

SENATOR SILVERSTEIN:

Sure. One more time for Senator Syverson. This prohibits a person from operating a motor vehicle when a person is smoking if a person under the age of eighteen of age is in the vehicle. The provision does not apply to an operation of a motorcycle, convertible with the top down. The bill -- bill imposes a maximum fine of a -- hundred dollars and states that an officer may not stop or detain a vehicle solely due to a violation or suspected violation of this Section.

PRESIDING OFFICER: (SENATOR LINK)

Is there any discussion? Senator Syverson.

SENATOR SYVERSON:

Just a couple questions.

PRESIDING OFFICER: (SENATOR LINK)

Indicates he will yield.

SENATOR SYVERSON:

Thank you. Senator, in most of these cases, if -- if there

is a -- if a family member or if you have child and your riding with them...

PRESIDING OFFICER: (SENATOR LINK)

Hold on, Senator Syverson. Please let's keep the noise down on the Floor, so they can hear one another. Thank you. Senator Syverson.

SENATOR SYVERSON:

Thank you. This is trying to get at, in most cases, I think, children that are riding in their -- with their parents in their vehicles. But in -- if that's the case and you have parents smoking, then these children are -- are going to be in the same home with these parents twenty-four hours a day. So that little bit of time in the vehicle, is it -- does it really have that kind of an impact then than what's -- than what's happening with their life anyways?

PRESIDING OFFICER: (SENATOR LINK)

Senator Silverstein.

SENATOR SILVERSTEIN:

I agree with your analogy, but I have to differ. When you're in a car, you're in a closed environment, windows might be up. In a house, you can smoke in another part of the house; you can smoke outside. So I think you're in a more confined area. This way, the smoke -- secondhand smoke is more dangerous and potent; there's more carcinogenics {sic} in that area. So I think it's -- it's much more dangerous smoking in the car than smoking in the house. But I do appreciate your point and your point is taken.

PRESIDING OFFICER: (SENATOR LINK)

Senator Syverson.

SENATOR SYVERSON:

Do other states have this law in place?

PRESIDING OFFICER: (SENATOR LINK)

Senator Silverstein.

SENATOR SILVERSTEIN:

Yes. There are six other states. Arkansas, California, Louisiana, Maine, Oregon, and Utah have adopted similar legislation.

PRESIDING OFFICER: (SENATOR LINK)

Senator Syverson.

SENATOR SYVERSON:

In those states, do they have the same rules that they can't be stopped for -- if they're smoking?

PRESIDING OFFICER: (SENATOR LINK)

Senator Silverstein.

SENATOR SILVERSTEIN:

That I do not know. That -- that -- I don't have an answer to that. But it's the same -- same concept.

PRESIDING OFFICER: (SENATOR LINK)

PRESIDING OFFICER: (SENATOR LINK)

Senator Syverson.

SENATOR SYVERSON:

I guess, a question. Who is going to end up being stopped by this? So, the only -- if you can't stop them for this, so the only time that they can be given this ticket is if they are stopped for a speeding ticket and -- and they determine that that person was smoking. And how do you determine that? If you have cigarettes in an ashtray or they have to have watched them smoke? And if they're working on a speed gun and getting 'em for speeding, how are they going to know if they were smoking at that time?

SENATOR SILVERSTEIN:

Let me just go back and -- I -- I just want to clarify my answer. Cities in Maine, New York, and New Jersey have also enacted similar ordinances. So this is nothing new. First of all, they don't -- if a person is going to be stopped for speeding, that's one -- one violation. They -- police officers cannot stop somebody solely for this violation. It's going to be within the discretion of the police officer, of course, something that we put a lot of discretion on, similar to if you're driving without a seatbelt - if someone pulls over -- are speeding and their not driving with seatbelts, within the discretion of the police officer what he or she is going to do.

PRESIDING OFFICER: (SENATOR LINK)

Senator Syverson.

SENATOR SYVERSON:

How many people do they think they're going to stop -- or how is this really going to prevent smoking if the only time they can be stopped is if their committing another traffic accident {sic}? How many people do we think this going to prevent from -- from smoking, knowing that it's not -- they can't be stopped for that? PRESIDING OFFICER: (SENATOR LINK)

Senator Silverstein.

SENATOR SILVERSTEIN:

This is a separate violation. If they get pulled over for speeding, that's one violation, and if they see 'em smoking, that's a separate violation. But they cannot stop them -- a person just because of -- of -- because of the smoking aspect. So -- and I don't have any raw numbers for you.

SENATOR SYVERSON:

Last question. Just on -- in -- in regards to how they enforce it, if -- if you have cigarettes in the ashtray, do they have to physically see them inhaling or blowing out smoke? Or how is that defined when they're saying smoking in the vehicle? If there are cigarettes in the ashtray, does that count?

PRESIDING OFFICER: (SENATOR LINK)

Senator Silverstein.

SENATOR SILVERSTEIN:

Bill says smoking means to inhale, exhale, burn, or carry a lit cigarette. So that would answer your question.

PRESIDING OFFICER: (SENATOR LINK)

Senator Lightford, for what purpose do you rise?

SENATOR LIGHTFORD:

Will the sponsor yield?

PRESIDING OFFICER: (SENATOR LINK)

Indicates he will.

SENATOR LIGHTFORD:

Senator Ira Silverstein, is there any opposition to this legislation?

PRESIDING OFFICER: (SENATOR LINK)

Senator Silverstein.

SENATOR SILVERSTEIN:

There -- there might be. I -- I have not -- my computer's not on, Senator Lightford, so I -- I have no idea -- I have no idea what the opposition is.

PRESIDING OFFICER: (SENATOR LINK)

Senator Lightford.

SENATOR LIGHTFORD:

There is. There's opposition to this bill, Senator. The Illinois African American Family Commission is opposed to this legislation. They've been opposed and they shared that opposition with you some time ago. I think the concern here -- to the bill, Mr. President.

PRESIDING OFFICER: (SENATOR LINK)

To the bill.

SENATOR LIGHTFORD:

The concern here is that in order to add another reason for law enforcement to stop a person in a vehicle, could increase the area of racial profiling, which is a big concern for the Illinois Legislative Black Caucus and the Illinois African American Family Commission. We stand in opposition to this legislation. We need not to have an additional reason at all for officers to stop moving vehicles. I personally feel if you're in the privacy of your own automobile, what you do is your own personal business. It's not a public restaurant, a public facility. I've voted for every secondhand piece of legislation that has come through this Chamber, but I think this right here is just a step too far, just went too far in the privacy of your own domain. I'm asking all of you and urging you to vote No on this legislation.

PRESIDING OFFICER: (SENATOR LINK)

Senator Bivins, for what purpose do you rise?

SENATOR BIVINS:

To the bill, Mr. President.

PRESIDING OFFICER: (SENATOR LINK)

To the bill.

This is an issue regarding kosher milk

Senator, I just had a quick question. Is there a difference between pasteurized and homogenized milk?

SENATOR SILVERSTEIN:

I -- I would have to defer to my seatmate over here. I -- I have no clue. Senator Sullivan may be able to answer that question.

SENATOR SILVERSTEIN:

My -- my expert witness says -- what? Oh! Oberweis. Senator Oberweis. What are we thinking here?

SENATOR OBERWEIS:

Homogenized milk is a process that breaks down the fat particles in milk so that they will not come back together. Before homogenization, the cream would rise to the top. With homogenized milk, it never rises to the top because it's totally broken down

and becomes part of the milk. Has nothing to do with pasteurization. Pasteurization is the process that kills bacteria in the milk.

It also requires the Department to address through rules and procedures the failure of individual staff at child care facilities or child welfare agencies to report suspected abuse, neglect of children with the facility. The Department must also adopt rules regarding the investigations of these reports that are committed by professionals working with children or adult residents. This has been carefully discussed. There has been many meetings. I believe there is no opposition to this bill and I would ask for the Body's approval.
