Thank you, Mr. President. Senator Morrison, can you go through with me, after we've done what we've done with the amendments, the -- the penalty that will now be in statute for not just a first offense under this, but second and subsequent offenses?

Ladies and Gentlemen, this is final action. Please hold the visiting down, please. Shh. Senator Morrison. SENATOR MORRISON:

Certainly, Senator Righter. Thank you for the question. Ιt will mirror that -- the same penalties as for a cigarette. A first violation is a petty offense wherein a court may impose a sentence of twenty-five hours of community service and a fifty-dollar fine. A second violation within twelve months is punishable by fifty hours of community service and a seventy-five-dollar fine. A third violation within twelve months of the first is punishable by fifty hours of community service and a two-hundred-dollar fine. With the recommendation of the State's Attorney, a court may order the minor and his or her legal guardian to attend a youth diversion program and -- if that program is available in the jurisdiction where the minor resides. This order may be in addition to, or in lieu of, any other penalty imposed, but attendance at the program should be credited against any community service imposed. PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Righter. SENATOR RIGHTER:

That's what I needed, Mr. President. Thank you, Senator

So, anyway, 224, as amended, clarifies that when the boundaries of any school district are changed by the attachment or detachment of a territory, the territory that is detached remains liable for its proration -- prorate share of the bonded

indebtedness and financial obligations of the school district from which the territory is detached. It also -- current law doesn't specify the factors that may be considered by the regional board, so this just clarifies the factors. I would urge an Aye vote and I'm happy to answer any questions.

Thank you. Is there any discussion? Senator Luechtefeld, for what purpose do you rise? SENATOR LUECHTEFELD:

Thank you, Mr. President. To -- to the bill. PRESIDING OFFICER: (SENATOR SULLIVAN)

To the bill, Senator Luechtefeld. SENATOR LUECHTEFELD:

You know -- we've had a lot of discussion in -- in -- in committee on this bill and -- and I know that Senator Bush has a -- a problem in her district that she's trying to solve. The point that I'd like to make to the -- to the entire Senate is that this is really -- this is really a big change. I mean, this is a -this is something big that all of us are involved in. It has to do with parts of -- of school districts wanting to detach, obviously, and go to another school district. There is a procedure to do that now that -- that schools follow. This will change that procedure, not just for her district, but for the entire State. Now, the State Board of Education is, from what Senator Bush said, is presently working on a proposal to do that, and -- and this is something, seriously, that needs to have a lot of discussion, because it has a lot of unintended consequences. The bill, as amended, I think is better. She -- she understands that, but is wanting to solve this in her district. But keep in mind that all

of us will have to live with this and we're not real sure what those unintended consequences will be. It is a very important bill. Many times, we, in -- in education, we have maybe a mandate that maybe isn't going to do a lot of stuff. This -- this does change things for all of us. So, again, you know, I voted against it in committee and I think several others did, at least on this side, wanting to wait for the State Board -- wanting to wait for the State Board to make some decisions as to -- a thoughtful decision, and I'm not -- she -- she's given this a lot of thought, obviously - I'm not trying to say that. But before you vote for it, just keep that in mind, if you would. Thank you. PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Is there any further discussion? Seeing none, Senator Bush, do you wish to close? Senator Bush. SENATOR BUSH:

Yes, thank you, Mr. President. I -- I thank you for your comments, Senator, although I would like to clarify you were the one vote against the bill in committee. But -- but anyway, so this isn't something that might happen. It's something that has happened, and this really isn't making any huge changes. It's just listing some -- basically some factors that should be considered, three, that -- when you are detaching from a district. It's happened in my district and this is something we should all be concerned about and -- and, certainly, it's not really a major change. But thank you and I'd urge an Aye vote. PRESIDING OFFICER: (SENATOR SULLIVAN)

This bill, as amendment -- as amended, creates a transit facility improvement area to fund the Union Station master plan, as well as CTA's Red and Purple modernization and the Blue Line modernization extension and the

Red Line south extension. This creates a tool to be used by the City, if they decide to do it. Timing is required now. We're dealing with this now because federal and State resources, as we all know, are -- for capital construction are limited. The feds now have -- instead of just a fresh start, they have a program that can enable us -- older cities to also use dollars for infrastructure development. So we need to provide matching dollars for that. This is a potential tool for them to do it. This would be for use in currently defined projects. Union Station, as we all know, has -- in great need of renovation. The Red and Purple modernization is like a 1.4 billion-dollar renovation needed. We also want to extend the Red Line down south and the Blue Line modernization enhancement program going towards the west side of the City. I'm happy to provide any more details you want. We've excluded the Chicago teachers from -- from this. CPS, Chicago Public Schools, are excluded from the TIF districts. That's defined as well. So they would not lose any money going forward on this. Happy to answer any questions.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Is there any discussion? Leader Radogno, for what purpose do you rise? SENATOR RADOGNO:

I have a question of the sponsor. PRESIDING OFFICER: (SENATOR SULLIVAN)

Indicates she will yield for questions, Senator -- Leader Radogno.

SENATOR RADOGNO:

Senator, you mentioned that they've excluded the Chicago Public Schools as an entity that would lose money. What are the

SENATOR STEANS:

Right. So it's the City of Chicago, the CTA, the Park District, and -- which one am I forgetting? Those and -- and I think I said the Park Districts.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Leader Radogno.

SENATOR RADOGNO:

Well, I believe Cook County was probably another one that will be on there. CPS is all that's excluded. My concern about this bill: As we all know, TIFs can be useful and you've certainly addressed the one that has received a lot of attention, and that is how schools are impacted by TIFs. But given the current state of affairs with the City of Chicago and the fact that they have recently stated point blank they need help from Springfield, it doesn't make sense to me to implement an opportunity for them to divert funds from their general corporate fund. I don't think Cook County is in a lot better shape. And so while these projects are important, some of them are transportation projects; CTA is going to be losing money on them. The -- much of the area around Union Station is already TIFed. So I understand you've made the bill permissive, but I just think we would not be smart to provide another temptation for the City of Chicago, already in near bankruptcy, to divert more money away from their corporate fund, as they come down here to ask us for a bailout. And for that reason, I would ask people to vote No for -- at this time. Maybe when everything is straightened out and we're back on track, it

would be wise to consider it, but I think this is not the time to do it and would strongly urge a No vote. Thank you. PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Further discussion? Senator Murphy, for what purpose do you rise?

Question of the sponsor, Mr. President. PRESIDING OFFICER: (SENATOR SULLIVAN)

Indicates she will yield. Senator Murphy. SENATOR MURPHY:

Senator, in -- in committee, I think we had talked a little bit about the impact on local available funds analysis under the general State aid formula. One of the concerns that -- that we have is that this TIF, which is a little bit of a unique product, it's a little different, the idea is to give money to CPS -- the idea is to give money to CPS to make them whole, but is the vehicle through which it's being given going to result in it appearing that Chicago has less available local funds, meaning they will get more money under the general State aid formula if this passes, as opposed to not?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Steans.

SENATOR STEANS:

This excludes CPS, so it should have no implications on that. PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Murphy.

SENATOR MURPHY:

And I appreciate that that's the intent, but how is this money getting to CPS?

Senator Steans.

SENATOR STEANS:

As it currently does. It just, you know, the -- whatever the current processes are in place. It just makes no change to them. There's just no impact there. So, all current mechanisms are in place to still do the valuations, EAV and all -- all of those things. It just doesn't change anything for them.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Murphy. SENATOR MURPHY:

Well, so it won't be -- so -- I -- I just want to make sure I understand. Because we're going to -- we're going to collect this money and then we're going to keep -- the Park District and the other entities, we're going to keep their increment, but we're going to give the increment to CPS. I -- I guess I don't know how they're going to collect only those other entities' part and not collect CPS's. My fear here, Senator, is that they're going to take it all and the money is going to go to CPS through the TIF. That's going to make it look to the formula down here as if that is unavailable local funds and the City is going to get more in general State aid because of that and it -- with all due respect, I appreciate what your intention is, but I don't have a lot of confidence that it's crystal clear as -- that that is going to be the way this goes, that -- that -- that it's not going to affect general State aid and -- and Chicago's local share available funds. And for that reason, I -- I -- I concur. I -- I can't support this bill without that level of clarity in how it's going to impact general State aid.

And what we do is introduce them to this wonderful organization, and I'd like you to welcome the -- these wonderful, gorgeous ladies from Mercy Ministries today. Thank you. Is there any discussion on Amendment 3? Seeing none, all those in favor will say Aye. Opposed, Nay. The Ayes have it, and the amendment is adopted. Mr. Secretary, are there any further Floor amendments approved for consideration? SECRETARY ANDERSON:

Senator Kotowski.

#### SENATOR KOTOWSKI:

Thank you very much, Mr. President, Ladies and Gentlemen of the Senate. This piece of legislation is something I've worked on with Life After Innocence project through Loyola University Law School. There's a group of students who've worked on this project and their director Laura Caldwell. And this particular initiative would create a grant program for people who've been -- received a certificate of innocence or have been pardoned by the Governor on grounds of innocence to be able to get a GED and, potentially, a college degree. These are people who've been wrongfully imprisoned and received a certificate of innocence. It is subject to appropriation. We could determine how much money we're going to allocate. We could determine to spend ten thousand dollars for what the -- GED program costs or to spend the total amount, which would be -- which would be close to four million dollars if we were going to be paying for all the tuition for -- 'cause there's about approximately -- this is not good news - there's about a hundred and eighteen people who've been wrongfully accused and received a certificate of innocence and spent a great deal of time in the prison system and they shouldn't have been. And so their lives are gone. They've lost their families. They've lost the opportunity to live the kind of life they were supposed to lead

and this is an opportunity to atone for that mistake. But, again, subject to appropriation, it's not specific as to the amount of money we're going to spend. We would have to make that determination as to how much funds would be available. PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Is there any discussion? Senator McCarter, for what purpose do you rise? SENATOR McCARTER:

To the bill, please. PRESIDING OFFICER: (SENATOR SULLIVAN)

To the bill, Senator McCarter. SENATOR McCARTER:

Senator, I -- I think you explained it fairly well, probably a little more detail than we -- we discussed in -- in -- in the committee. I -- I think there's none of us that don't want to help those who have been exonerated, yet I just need to remind everyone this is subject to appropriation. You've heard it once. You've heard it twice now. And it does not just include a GED. It does include a full -- full paid tuition, if it is approved, for higher education. This could be one of those things that we have to decide if it's a priority. It's not that it's not a good thing, but I think in the challenging times that we have today, this is one of those decisions where we have to decide what we can do and what we should do. And so I don't think anyone here disagrees that this wouldn't be a great opportunity to help someone, but I question whether this is the right time and this is a priority. So I -- I ask that -- I'd ask that you vote No. PRESIDING OFFICER: (SENATOR SULLIVAN)

Further discussion? Senator Righter, for what purpose do you

Thank you. Senator, when -- when I first saw that you were on your feet presenting a bill and listened to you talk a little bit, I thought that this was the bill that you had been carrying that increased the payout we give to individuals who -- and obviously it's not that. What's this -- and I -- and I understand this is outside the four corners of the bill, but it relates to the same, if you will, classification of people we're trying to assist. Increasing the payout, what's the status of that bill? Do you expect that bill to come off the Senate Floor? PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Kotowski.

SENATOR KOTOWSKI:

I -- I'm not sure. We've been sitting down having some discussions about that other piece of legislation, trying to figure out what -- what would be fair. I don't have a resolution yet on that other bill. This is something that I've been working on separately as well.

Thank you, Mr. President, for your indulgence on that. Senator Kotowski, based on the number of individuals who were exonerated or issued certificates of actual innocence, how much

would this program have cost last year if it were fully... PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Kotowski.

SENATOR KOTOWSKI:

You know, that's an interesting question, Senator Righter, because if you look at participation rates for people who are adults who attend college over the age of thirty-five, which most of these people are, the participation rate is very low. It's about six percent. So if you look at the total number of people who would fall under the definition of people who have received a certificate of innocence or pardon on the grounds of innocence, you know, there's -- there's a hundred and eighteen people, but the number of people who would be able to take advantage of this program, you know, it would probably be relatively small, and that's sad given the state of affairs that they've spent -- you know, we had a gentleman here - and you saw him testify in committee - he spent twenty-five years in jail for being wrongfully imprisoned. So I don't know how many people are going to take advantage. There's some estimates that, you know, it could be, you know, twenty-five percent. It could be six percent. I -- I think the bottom line is we're going to make this program available and we would determine how much we would want to allocate - as the previous Senator spoke about, you know, whether or not we would determine this is a priority. I would say that I think it's important to note that we invest an incredible amount of money in -- in putting people in jail and paying for Corrections and public safety. And, you know, and I -- and we -- it's -- it's a huge component of our budget. It's multi-billion dollars and this is an area that we need to look at to be able to, as I said, to -- to

atone and -- and -- and address mistakes that may have been made. So, I can't tell you the specific number, but I think that's why it's subject to appropriation. I can tell you the total eligible universe, which is a hundred and eighteen people, which is a sad number who've received a certificate of innocence.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Righter.

#### SENATOR RIGHTER:

To the bill, if I might, Mr. President. Thank you very much. Ladies and Gentlemen of the Senate, I rise in truly reluctant opposition to this and this is why. It's not -- it doesn't have to do with the whole "subject to appropriation" debate that sometimes we get into in this Chamber. It's based on two things: First, you are raising expectations. When something like this passes and there is publicity from this, and there will be, then there's an expectation out there that, wow, the Members of the General Assembly and the Governor have said we're going to do this for these people, and then when the dollars aren't there, that was an unfair expectation to raise. The second issue is, we already, Mr. President, tell certain classes of people that we are going to pay all or part of their education. We tell that to students who are eligible for MAP grant funding, who don't get it. We tell that to veterans with regards to the scholarship programs and we don't pay for it. And there are select tuition waivers that come from the General Assembly that are also not paid for. Why add another group? Regardless of the merit that may be attached to their argument, why would we add another group to that category of people whose promises we are not fulfilling? For that reason, Mr. President, I would urge a No vote.

SENATOR BIVINS:

Thank you, Mr. President. You know, while I think it's a travesty that anybody would be wrongly accused of a crime and have to spend twenty-five years or even a day in -- in prison or jail, one thing needs to be pointed out that I -- I discovered in -- in Appropriations Committee when we had DOC in, that they do offer educational opportunities. They have -- they have two-year college, four-year college, GEDs. They have over twenty -- I think it was twenty-two vocational education opportunities awarded. So there -- there are opportunities, and -- and while -- we also have those individuals who will probably more than likely get settlements civilly. And -- and given the State's current condition, I don't think this is something that we can afford right at the time and it's not to be without compassion for those who have been wrongly confused -- convicted. Thank you, Mr. President. PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Senator Lightford, for what purpose do you rise? SENATOR LIGHTFORD:

Thank you, Mr. President. To the bill. PRESIDING OFFICER: (SENATOR SULLIVAN)

To the bill, Leader Lightford. SENATOR LIGHTFORD:

Mr. President, Ladies and Gentlemen of the Senate, I rise in support of this legislation, because I know when individuals are children - let's start with them - when we discipline them at home for something they did or maybe they did not do, there's repercussions. As adults, when we're accused of doing things in our profession or even with our family members that perhaps we didn't do, there's repercussions. But when you accuse someone who did not commit a crime and they spend their lives in a prison system, I think we owe them. We owe them a lifetime of opportunity of what they have left. I know that they offer GEDs in prison, but if I was wrongly accused and I was in prison, maybe I'm too depressed, maybe I'm too -- I'm filled with too much anxiety and stress to even think that there is hope for me to go beyond where I am because I'm wrongfully there. I'm wrongfully convicted. I think the least we can do is allow these individuals an opportunity for when they are able to work and they're back in the communities, maybe they find a profession that they're interested in, and help them to be able to achieve the goal of attaining a degree. We're not giving out honorary degrees by the way. We're offering them an opportunity to put themselves back within our society, giving them just a little bit of hope for the years that we've taken away from them. I commend the sponsor, because I think this is a great step in the direction to, one, say I apologize for ruining your life for all those years, but I'm going to give you a little bit of assistance, just a little bit, to help you start a new life. And we all know that education is the key to attaining that goal. So I rise in -- in support of this legislation, because it doesn't matter if it's subject to appropriation; it doesn't matter if we raise the expectation. What we have to do is give people hope and

especially those that have been wrongfully convicted. I hope we do make this a priority of this General Assembly. I, again, commend the sponsor and I -- I encourage an Aye vote. PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Senator Kotowski, to close. SENATOR KOTOWSKI:

Thank you. I -- I appreciate your -- your comments, Leader. I'm -- I'm grateful for that and I'm grateful for all the questions that were asked today, and I would like to respectfully ask that a previous statement that was made that the Senator reconsider his thoughts on this bill, reconsider his position, because some of these people who've been wrongfully incarcerated for twentyfive/thirty years are at the -- way back of the line in terms of their eligibility for these programs to -- for them to order -- to get more of an education. So it's another injustice that actually has been committed against them. So not only have they been wrongfully imprisoned for twenty-five/thirty years, they're not able to be as eligible for the programs as other people are for some of these crimes that were considered to be committed. And so I think that's something to consider and I hope the previous speaker will reconsider his position. So the goal of this bill is not just to -- we heard some words about raising expectations, but to raise consciousness and raise awareness and to make people realize that when people are wrongfully imprisoned and they receive the certificate of innocence, that we're actually not doing anything for them. And the vast majority of people as it stands who -- who leave the Department of Corrections do not have a GED, do not have any kind of advanced degree. So we're actually sentencing them to not only the fact that they're no longer a part

of society, no longer a part of their family, their community, we're sentencing them to their future of -- a very bleak future without an opportunity for success. And so this is an opportunity to be able to address the fact that a mistake has been made. And I just want to be clear about something, because I think this is very important, and we're talking about just for a GED, 'cause most of these people who have been wrongfully imprisoned and received a certificate of innocence, for a GED, it costs a hundred and twenty dollars to get a GED. And to not make a hundred-andtwenty-dollar commitment for someone who's been in jail for twentyfive years, I think is criminal. So, quite frankly, I would -- I would ask for your Aye vote on this and I appreciate your consideration and your questions. Thank you. PRESIDING OFFICER: (SENATOR SULLIVAN)

Ladies and Gentlemen, the question is, shall Senate Bill 223 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Secretary, take the record. On that question, there are 35 voting Aye, 18 voting Nay, 1 voting Present. Senate Bill 223, having received the required constitutional majority, is declared passed. Ladies and Gentlemen, if you'll turn to page 30 of the regular Calendar, on the Order of Resolutions, we have Senate Joint Resolution 2. Senator McCann, do you wish to proceed? And the seven brothers' names are Adrian, Arthur, Earl, Everett, Fred, George, and Max Powell.
